Dear Mr. President:

On behalf of the National Association of Clean Air Agencies (NACAA), we write to offer our association's perspectives on your *American Recovery and Reinvestment Plan*. We commend you for seeking to address the economic crisis facing our nation, and support your desire to save and create jobs, jumpstart the economy and lay the foundation for recovery. However, as we explain below, it is critical that investment in our nation's infrastructure ensure that projects enhance, not impede, environmental protection.

The members of NACAA – an association of air pollution control agencies in 53 states and territories and over 165 metropolitan areas across the country – are invested with primary responsibility for ensuring clean, healthful air for our citizens. As such, NACAA applauds the inclusion in the Plan of measures to spur a clean energy economy. These measures – such as increasing capacity to generate alternative energy sources; transforming the energy grid to improve the transmission, distribution and production of clean energy; making public buildings more energy efficient; weatherizing homes of low-income families; and financing grants and loans to state and local governments for projects that reduce diesel emissions – will not only reduce our dependence on foreign oil, but also yield critical environmental and public health and welfare benefits, including greenhouse gas reductions that will aid in the fight to stem global warming.

NACAA also recognizes the vital importance of measures related to the other priority areas identified in your Plan. We note with great interest the rebuilding of America's roads and bridges and investments in infrastructure, for which you propose to dedicate tens of billions of dollars. We embrace your vision with respect to the role of this priority in our nation's economic recovery. At the same time, we are reminded of your firm and often-expressed belief that robust economic growth can and should live side by side with responsible stewardship of our environment, including our air. We are also aware that two of your top five environmental priorities are reducing greenhouse gas emissions and decreasing other air pollutants. Therefore, we strongly encourage that the selection of road, bridge and other infrastructure projects to be funded under your Plan include a "green screen" process to ensure the stimulation of infrastructure projects that will enhance, rather than impede, protection of the environment and public health and welfare. For example, road and other construction projects should be subject, among other things, to appropriate site selection criteria and requirements for the use of low-emitting construction equipment fitted with advanced emission control technologies; road paints low in volatile organic compounds; and strategies to reduce, reuse and recycle materials.

Toward this end, Mr. President, once your Plan is adopted by Congress and signed into law, we respectfully recommend that it be accompanied by an Executive Order to departments and agencies in your Administration directing that stimulus funds be disbursed based on criteria that are consistent not only with your economic priorities, but also with your environmental priorities.

A healthy economy goes hand in hand with a healthy environment and a healthy population. We hope you will agree it is critical that, when implemented, the *American Recovery and Reinvestment Plan* can and should remain faithful to all of these goals.
