

National Association of Clean Air Agencies Survey on MATS Compliance Extension Requests

October 9, 2014

The Mercury and Air Toxics Standards (MATS), issued on December 21, 2011 (published in the *Federal Register* on February 16, 2012¹), are intended to limit emissions of mercury, acid gases and other toxic pollution from power plants. MATS calls for a three-year compliance period for existing sources, with a deadline of April 16, 2015, but provides for an extra year, upon request, for sources that need additional time to comply.

The National Association of Clean Air Agencies (NACAA)² has conducted surveys to determine how many requests for one-year MATS compliance extensions (under 40 CFR 63 Subpart UUUUU) state and local agencies have received and how many requests have been granted. The following table contains updated information from 66 agencies in 47 states, DC and Puerto Rico. According to the responses, to date:

- 145 extension requests have been made;
- 133 requests have been granted;
- 9 are under consideration;
- 2 were denied due to incomplete information; and
- 1 request was accommodated through a permit waiver
- 2 more requests may be forthcoming

According to EPA's Regulatory Impact Analysis, there are 460 coal-fired power plants that are affected by the MATS rule. Therefore, only approximately 32 percent of the plants have indicated that they need additional time to comply and, of those, 92 percent have been granted an extension.
