⁴ This is a complicated site. The aerial photo shows 9 buildings which is likely the first 2 permits 61193 and 61194. In October 2002, a permit was issued to add 16 new layer buildings and 4 new pullet buildings for 2.5 million birds (Pullets are less than 3 lbs. each and layers are 3-4 lbs. each.). IDNR does not know how many animals are at this facility.

⁵ This is one of the DNR air quality monitoring sites, with the monitoring location located about ½ mile SW of the SW building corner (1/4 mile SW of the SW corner of the lagoon).
